IMPLEMENTATION OF DISCIPLINARY COMMITTEE REPORT PURSUANT TO ARTICLE 4 (4)(2) OF THE NPP CONSTITUTION

RE: MISCONDUCT BORDERING ON ANTI-PARTY BEHAVIOUR

- 1. At its meeting on the 25th January, 2025 the Regional Executive Committee referred complaints of anti-party misconduct against constituency executives, electoral area coordinators, polling station executives, former executives and other party members to the Regional Disciplinary Committee for investigations:
- 2. Following the referral of the complaints to the Regional Disciplinary Committee, the individuals affected were suspended pending the conclusion of the Regional Disciplinary Committee on the 20th February, 2025;
- 3. On the 22nd and 23rd March, 2025, all of the suspended individuals were invited to appear and majority of them appeared before the Regional Disciplinary Committee at the Regional Secretariat, Bolgatanga to be heard;
- 4. Upon conclusion of hearing, the Committee conducted a number of investigations on the hearings and compiled its report:
- 5. The Regional Disciplinary Committee having concluded its mandate into the anti-party behaviour exhibited by some Constituency Executives, Electoral Area Coordinators, Polling Station Executives and other members of the party before and during the 2024 general elections in the Pusiga and Tempane Constituencies submitted its report to the Regional Executive

Committee on the 20th June, 2025 through the Regional Chairman;

6. The Regional Executive Committee at its meeting on Friday, the 1st day of August, 2025 deliberated on the report and accepted the unanimous decision and recommendations of the Regional Disciplinary Committee on all the Twenty-One (21) party officials and members from the Tempane and Pusiga Constituencies.
